All dues/payments are due April 1 of each year. All monies received after April 1 will be charged a late charge. Annual dues are subject to change based on annual operating / maintenance expenses.

Use of the WSSC facility is limited to members in good standing and their children living at home. Children or family members who do not reside in the member's home on a permanent basis are not covered under membership and are considered guest.

Guest: All guests will be charged a fee of \$5.00 per person per day except for out-of-town, in-house guest which may use the pool without charge. Guests must be accompanied by a member.

Babysitter Fee: Members in good standing can pay a flat "babysitting fee" of \$50 per year which allows one non-member (child care provider) use of the facility when accompanied by the member's child/ children.

Grandchild Fee: Members in good standing can pay a \$25 fee per grandchild per year which will allow their grandchildren use of the facility when accompanied by a grandparent who is a member.

Pool Rental: Members can reserve the pool for private parties. A member must remain at the pool at the pool throughout the rental period. Member reserving the pool will be responsible for the conduct of all persons present and for any damages, etc.
